## **Professional Disclosure Statement**

Philosophy and Approach: Therapy at Radical Families will be performed primarily from a family systems lens, wherein each member of the family has a valuable role and responsibility to the well-being of the whole. I am interested in experiential and phenomenological therapeutic interventions, which involve child-led interventions such as play and sandtray therapy, and adult-led interventions to build a deeper awareness of blocks and growth edges in the parenting role. In addition to focusing on the therapeutic relationship between you and I, which will be the primary catalyst for change, we will work together to exercise curiosity regarding relational/interpersonal concerns, intrapersonal distress (i.e. feeling conflicted about setting boundaries or how to enact consequences), fixed narratives that govern action, larger narratives of oppression or disenfranchisement, and/or repetitive figures or patterns interfering in your family life. My belief is that the efficacy of the intervention lies in the therapeutic relationship, so my desire is to create a safe place for you to explore whatever might emerge in our work together.

Education and Training: I am a Licensed Professional Counselor registered with the state of Oregon. I hold a Master's degree in Mental Health Counseling from Lewis and Clark College, Graduate School of Education and Counseling in Portland, Oregon a CACREP accredited institution. My coursework in preparation for working with you included counseling interventions with adults individually and in groups, counseling trans, genderqueer, and LGBidentified clients, addictions and substance abuse training, and trauma and crisis counseling. I have continued professional training in ASIST suicide prevention training, as well as receiving a post-graduate certificate in Adoptive and Foster Family Therapy through Portland State University. I am concurrently employed through a mental health agency where I receive ongoing training and supervision in Child Parent Psychotherapy, an evidence-based model for treating children and families who have experienced complex developmental trauma in the family system. My professional training and employment have afforded me the opportunity to work with a wide range of people in outpatient mental health, including those experiencing a range of difficulties, from systems-issues such as addition and poverty, as well as mental health concerns related to trauma, depression, anxiety, psychotic symptoms, attachment disturbances, as well as identity concerns such as shame, body/gender dysphoria, and grief and loss.

As a Licensed Professional Counselor registered with the **Oregon Board of Licensed Professional Counselors and Therapists, I abide by its <u>Code of Ethics</u>.** As a registered LPC, I receive ongoing supervision and am required to engage in 40 units of continuing education in various disciplines within the field every 2 years. Additionally I seek confidential supervision from Michael Weiner, LCSW, and participate in peer consultation in order to provide the

## Fees are as follows:

- \$150 out of pocket per 55 minute session
- \$250 per 90 minute tune up session for ongoing/previous clients
- \$150 for peer-to-peer clinical consultation
